1. Applicant **must** fill out Business – Owner and Applicant sections of permit.
2. Applicant **must** fill out Effective Date
3. Applicant **must** note what they will be selling in the Other section of the application
4. Applicant **must** provide a letter of permission stating exact location where they will be setting up their structure
5. Applicant **MUST PAY \$75** fee to be issued the application
6. Applicants area must be set up and ready for inspection **Friday June 23, 2017 at 1:00pm.**
7. If applicant is **preparing** food on site – appropriate Wayne County Health Permits will be required at time of inspection.
8. Make 2 copies of Application – Fire Department gets original – Yellow Copy to Treasurer’s Office and Pink copy to Applicant.
9. Send Original Application to Chief Mike Sypula at the Fire Department.
