**1) Letter from Mayor; Re: Bid for Purchase of Fire Equipment, was read:**

Moved by Ganzberger, supported by Zamecki; RESOLVED that the Southgate City Council hereby adopts a resolution awarding the bid for purchase of Fire Equipment (Personnel Protective Coats and Pants) to Douglass Safety Systems (2655 N. Meridian Rd, Suite 6, Sanford, MI 48657) in the amount of \$21,559.12. FURTHER RESOLVED that sufficient funds are available from the FEMA AFG grant with a 10% match (\$2,155.91) from the Fire Department budget for this purchase.

**2) Letter from Mayor; Re: Bid for construction Improvements Reeck and Devoe Drainage, was read:**

Moved by Zamecki, supported by George; RESOLVED that the Southgate City Council hereby adopts a resolution awarding the bid for Construction Improvements Reeck Road and Devoe Drainage be awarded to RJ&J Enterprise, Inc. (10229 Dixie Hwy, South Rockwood, MI 48179) in the amount of \$167,085, with the addition of a 10% contingency and permit fees. FURTHER RESOLVED that sufficient funds are available in the Municipal Street Fund to cover costs associated with these improvements.
