Moved by George, supported by Rauch, RESOLVED, that the minutes of the Regular City Council Meeting dated October 21, 2020 be approved as presented. Carried unanimously.

Consideration of Bids

1. Letter from Mayor; Re: Purchase of Lions Park site Furnishings moved by Farrah, supported by Zamecki, RESOLVED THAT the Southgate City Council hereby awards the bid to purchase Lions Park Site Furnishings to Midstates Recreation (1279 Hazelton-Etna Road SW, Pataskala, OH 43062) in the amount of \$59,975 plus a 10% contingency for a total of \$65,972.50 BE IT FURTHER RESOLVED THAT the Parks and Recreation Millage Funds will cover \$15,972.50 of this Capital Improvement, with \$50,000 being covered by a grant from the office of Wayne County Commissioner Joe Palamara.

2. Letter from Mayor; Re: Purchase of Cobb Park Site Furnishings moved by Zamecki, supported by George, RESOLVED THAT the Southgate City Council hereby awards the bid to purchase Cobb Park Site Furnishings to Penchura LLC (889 S. Old US 23, Brighton, MI 48114) in the amount of \$122,423.55 plus a 10% contingency for a total of \$134,665.90. BE IT FURTHER RESOLVED THAT Parks and Recreation Millage Funds will cover this Capital Improvement.

Motion carried unanimously.

3. Letter from Mayor; Re: Library Pathway Improvements moved by George, supported by Zamecki, RESOLVED THAT the Southgate City Council hereby awards the bid to purchase the Library Pathway Improvements to C&S Construction Management (1202 6th Street, Wyandotte, MI 48192) in the amount of \$78,500 plus a 10% contingency for a total of \$90,275. BE IT FURTHER RESOLVED THAT Library Millage Funds will cover costs of this Capital Improvement.

Letter from Mayor; Re: Columns and Fencing for the Trenton Road Kiwanis Park Project moved by Zamecki, supported by George, RESOLVED THAT the Southgate City Council waives the bid procedure and authorizes purchase of Columns and Fencing for the Trenton Road Kiwanis Park Project to Sole Building Company (5940 Commerce Dr., Westland, MI 48185) in the amount of \$17,050 with a 10% contingency for a total cost of \$18,755. BE IT FURTHER RESOLVED THAT adequate funds are in the Major Street Fun for this purchase.
